Highlights, Activities & Updates of the Chapter

- 1) **Institute of Chartered Accountants of India** (**ICAI**) set up its first chapter in European Union at Amsterdam in The Netherlands. Official launching of the Institute of Chartered Accountants of India, The Netherlands Chapter took place in the year 2017 in Amsterdam at World Trade Center. This marked the first presence of ICAI in the European Union. This set up enhances the brand building of CA profession in Europe, create network and job opportunities for CA's and boost bilateral business between India and Europe.
- 2) Since the formation of the chapter, **CA brand** has got **strong recognition** by corporates and various governmental institutions. In four and half years of the chapter's existence, Chapter has organized various events, webinars, meetings and sessions for the CA members of The Netherlands.
- 3) In order to take care of the affairs of the Netherlands Chapter, the **managing committee** and working committee was formulated. Managing committee comprises of CA Vikas Chaturvedi (Chairman), CA Prashant Savla (Vice Chairman), CA Govind Sharma (Treasurer), CA Radha Nikhade (Secretary), CA Rahil Mehta and CA Debasish Dasgupta. Working committee comprises of CA Hardik Shahand, CA Ashraf Reshamwala and CA Ashok Patel.

- 14) This edition has **launched two more European Representative Offices of ICAI (with 2 CPE Hours)** in Denmark (Copenhagen) headed by Mr. Padhya and Sweden (Stockholm) headed by Mr. Gandhi. Next to the existing ICAI Netherlands Chapter, this brings the total number of ICAI Representative Offices in Europe to seven. These others are located in Belgium, France, Switzerland, Germany and Finland. Mahavir Singhvi, Joint Secretary Minister of External Affairs, congratulated the new representative office and suggested closer collaboration between the various offices now in Europe and beyond would help in supporting self reliant India.
- 15) ICAI Netherlands Chapter organised a webinar on Environmental, Social and Governance Disclosures – Accomplishing Value with Values in Business (with 2 CPE Hours) held on 13th December, 2021. Past President CA Atul Gupta was the speaker for the webinar.

Today, The Institute of Chartered Accountants of India (ICAI) is present in 64 locations worldwide and aims to be at 100 locations by 2024. ICAI overseas Chapters alongwith Ministry of External Affairs (through various Indian Embassies) are playing big role in Atma Nirbhar Bharat Mission of Narendra Modi ji.
- 20) In 7 days Executive Development Program of ICAI for CA's on behalf of ICAI Netherlands Chapter, CA Vikas Chaturvedi participated and moderated session on career opportunities in Americas, Europe, ASEAN and Oceania.


